



SAS SOFTWARE REQUEST INSTRUCTIONS

In order to **determine and account** for the accurate numbers of NJ SAS Windows Clients by Agency/Departments, we are now requiring that the attached form be correctly completed by each individual NJ SAS User, signed and approved by their Agency/Department Director or IT Director and returned back to me prior to the distribution of SAS Media, SAS Installation keys and/or Renewal licenses (Keys). The NJ Agency/Department Directors or IT Directors are aware of this new procedure. Therefore kindly comply with the new procedure below.

SAS Software: Latest version is v9.4.

Attached is the **SAS Software Request Form.**

Please see **State of New Jersey IT Policy, 14-12-NJOIT Software License Management and Distribution.**

Complete the attached SAS Software request document including an approval by your Agency/Department Director or IT Director.

Return the completed SAS Software request document by email to Bai.David@tech.nj.gov or faxed to Bai David at (609) 633-0188. If faxed, please send email notification.

SAS keys/Installation and Renewal licenses (keys) will be emailed to your work email address entered on the returned SAS Software Request document.

If SAS installation media is needed, it must be picked up in person.

SAS Version 9.2 is supported on 32 bit versions of Windows.

SAS Versions 9.3 and 9.4 are supported on 32 & 64 bit versions of Windows 7 and Windows 8.1.

SAS Versions 9.4, supported on 64 bit versions of Windows 10.

To determine if you need the 32 or 64 bit version;

1. Left click **Start**
2. Right click **Computer**
3. In the drop down list, left click **Properties**
4. Under **System**, find **System type:**
